**Eligibility:**

- Resident must not have visiting restrictions.
- Residents classified C5 and housed in the Secure Management Unit will need to be requested and approved a visit through the Unit Lieutenant a minimum of 5 days prior to the date of the proposed visit.

- Visits will be processed in accordance with visitor arrival times, unless prior approval is provided, to support security operations and the visit rooms operational capacity.

Attorney Visits:

- Attorney visits shall be conducted during the designated Attorney Visit time or during the designated housing unit in which the resident resides.
- Attorney Visits for residents classified C5 and housed in the Secure Management Unit will be conducted in the non-contact room.
